



LET YOUR CONVERSATION BE ALWAYS FULL OF GRACE

Let your conversation be always full of grace, seasoned with salt, so that you may know how to answer everyone.

(Colossians 4:6)

Colossians was written when Paul received news (probably from Epaphras) about some heresies starting to take root in Colossae. That false teaching was the beginning of what later became Gnosticism. Therefore, Paul's letter to the Colossians intended: 1) to emphasize the deity and supremacy of Christ in the face of the Colossian heresy; 2) to encourage the Colossian believers to stand firm in their original faith; and 3) to lead and motivate them to spiritual maturity. For example, Paul reminded them to continue to live in Him, rooted and built up in Him, to be strengthened in the faith as they were taught, and to be always overflowing with thankfulness (2:5-8).

It's common for Paul's epistles to have the first part dealing with doctrine and the second part about living out the truth/doctrine, and so it is the same for his Epistle to the Colossians. The doctrinal part is found in the first two chapters with the main theme developed in the second chapter. He warns them against being drawn away from Him in whom dwelt all the fullness of the Godhead, and who was the head of all spiritual powers (2:9-10). Given that Christ is the head of the body of which they are its members, if they are truly united to him, what else did they need?

The practical part of the Epistle (chapters 3-4) enforces various duties naturally flowing from the doctrines he expounded. They are ex-

horted to mind things that are above (3:1-4), to mortify every evil principle of their nature, and to put on the new man (3:5-14). Many special duties of the Christian life are also insisted upon as the fitting evidence of the Christian character.

There is also a remarkable resemblance between this Epistle and that written to the Ephesians if we compare the many practicalities exhorted, such as, "redeeming the time" (cf. Eph. 5:16 & Col.4:5).

In Colossians 4, the last chapter, Paul wrote about how a disciple of Jesus should behave or conduct himself in a heathen, gentile, or non-believing world, especially when his very dear faith in Christ is under challenge.

Let us focus on 4:6: "Let your conversation be always full of grace, seasoned with salt, so that you may know how to answer everyone." While the aim of this statement is placed in the latter part, that "you may know how to answer everyone," let's pay attention to the first part: "let your conversation be always full of grace."

What is "conversation full of grace"? And how would and should it be like?

Conversation full of GRACE

What is grace first of all? Well, it is something good done or given to someone who does not deserve it; in other words, it is unmerited favor. So, what would "conversation full of GRACE" be like then?
